EXHIBITOR INFORMATION

All food and beverages within the exhibit halls must be ordered through OVG Hospitality, the exclusive catering service for the Atlantic City Convention Center. Outside food and drinks are not permitted unless prior written approval is obtained from OVG Hospitality Management.

If you bring items without this written consent, you will need to remove them from the venue. This policy also applies to promotional items such as bottled water, popcorn, candy, and similar products.

- Alcoholic beverages may not be brought onto the premises during any event.
- We require 100% advance payment of the food & beverage/service ordered along with a signed contract
- All orders subject to a 23% catering supplement fee plus applicable NJ State Tax. If an exhibitor requires tables for food service, arrangements are made through the show's decorator.
- A final guarantee of attendance is required (7-10) business days prior to all food and beverage events.
- Cancellation policy - any cancellations made less than (72) hours in advance will be subject to a cancellation fee up to the full price of the order.



FOOD & BEVERAGE SAMPLING

Atlantic City Convention Center exhibitors may distribute food & beverage samples in authorized space and must not be in competition with products or services offered by OVG Hospitality. Samples must be representative of products manufactured or sold by the company exhibiting. Samples are limited to 4oz for non-alcoholic beverages and 2oz for food sample. Any vendor requesting to provide samples greater than 4oz; nonalcoholic beverages and 2oz; food will be subject to a buyout fee of \$150 each. Exact descriptions of sample and portion size must be submitted for written approval 30 days prior to the opening of the event. The distribution of alcoholic beverages is strictly prohibited. Any exhibitor giving away samples in their booth must have a valid state permit and all appropriate fees on file with the New Jersey Department of Health.

BOOTH BUYOUT

Exhibitors at the Atlantic City Convention Center may receive approval to offer distinctive food and beverage products that might not be readily available. This process is categorized as a food and beverage buyout. Arrangements must be coordinated ahead of time with the OVG Hospitality Department. Buyout fees apply.

HOW TO SUBMIT APPLICATION AND/OR ORDER

All information including payment information must be received two weeks prior to show start to guarantee delivery.

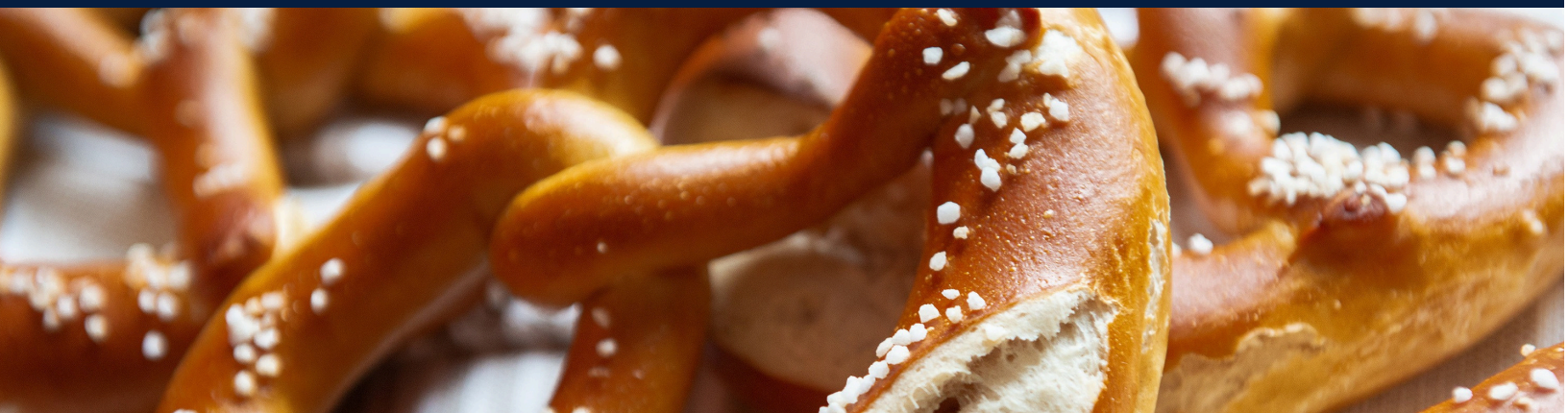

BAR SERVICES

CASH BARS

A bartender is required for all bar services. The fee for each bartender is \$300 for up to four (4) hours of service, with an additional charge of \$40 for each additional hour. However, this fee will be waived if sales reach \$800 or more per bartender. This pricing includes disposable service items.

Recommendations

- 1 bartender for every 100 guests for a full bar
- 1 bartender for every 150 guests for beer and wine bars

Space Requirements

Adequate space must be provided for the bar setup within the booth, ensuring that it aisles are not obstructed.

EXHIBITOR SAMPLING GUIDELINES

The practice of exhibitors bringing in their own food or beverage is in direct conflict with the OVG Hospitality exclusive contract at the Atlantic City Convention Center. Therefore, it is our policy that any exhibitor who is providing ANY food or non-alcoholic beverage items is required to notify OVG Hospitality in writing as to the nature of the proposed product giveaway (fees are applicable unless waived by OVG Hospitality or purchased through OVG Hospitality).

Sampling of food or non-alcoholic beverages will not be allowed if the item being dispensed is unrelated to the exhibitor's business. For example, this applies to companies or organizations that do not produce or sell these items in their regular operations.

OVG Hospitality and the Atlantic City Convention Center mandate that all food and non-alcoholic beverages must be served in sample sizes: (2) oz portions for food and (4) oz cups for non-alcoholic drinks. Additionally, written approval from OVG Hospitality must be secured at least 30 working days before the show opens.

If your sample requires you to cook on the show floor the following are approved cooking apparatus: George Foreman Grills, Panini Grills, Induction Cookers, Butane Stoves, Toaster Ovens, Sauté Pans (not using grease or oils), Pressure Cookers, and Deep Fryers with built-in suppression Systems and NJ State Fire Inspector Approval.

NOT APPROVED: ELECTRIC GRILLS OR ANY ITEMS CREATING GREASE LADEN VAPORS.

INSURANCE REQUIREMENTS

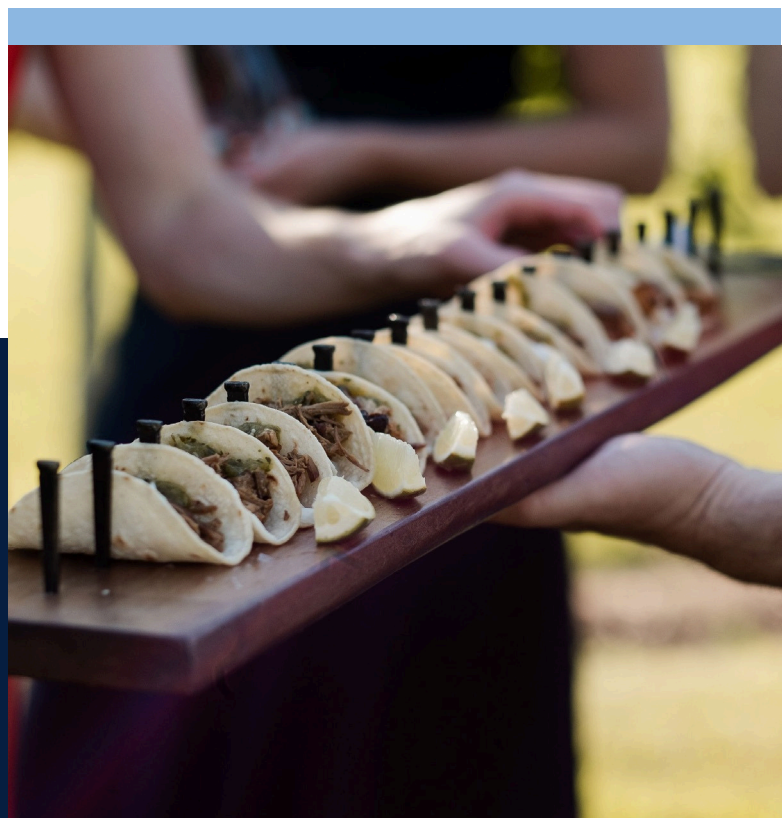
General Certificate Liability Insurance for \$2,000,000 each occurrence and \$2,000,000 aggregate. Certificate must name as additional insured OVG Hospitality and Atlantic City Convention Center on a primary/noncontributory basis.

Any exhibitor providing samples of food and non-alcoholic beverage must operate within the local Health Department Guidelines.

All food preparation booths must be free of any combustible materials and equipped with at least one (1) 20 BC rated fire extinguisher. If you're using open flame units, a fire permit will be necessary. For further information, please consult your Event Manager.

Any Exhibitor requesting to give away samples of alcoholic beverages must obtain a special event liquor license from the Liquor Control Board for the State of New Jersey. (Fees are applicable unless waived by OVG Hospitality or purchased through OVG Hospitality). Samples dispensed are limited to those products that are manufactured, processed or distributed by the entity requesting permission. Please refer to the Exhibitors Agreement for further specifications. You must hire an OVG Hospitality union bartender to serve alcoholic beverages. Bartender fee is \$300.00 four hour minimum, \$40.00 for each additional hour. Samples are limited to (1) oz of beer or wine, (.5) oz of spirituous liquors.

Alcoholic Samples are strictly for individuals aged 21 and older. Each booth must display a prominent sign that reads: *Guests must be 21 years of age to participate in the sampling of alcoholic beverages. A picture I.D. is required.*



SAMPLING AUTHORIZATION FORM

Submission Guidelines for Product Sample Distribution: Kindly provide the following information for the approval to distribute product samples. When preparing your samples, ensure that you adhere to all sampling and food preparation regulations outlined in the guidelines.

- Only food and beverage manufacturers are permitted to serve sample portions that are "bite size," with a maximum of (2) oz for food products and (4) oz for non-alcoholic beverages.
- Certificate of Insurance must be submitted for approval.
